HWBB.12 MINUTES

HWBB.13 COVID-19

The board received a verbal update on the latest Covid-19 epidemiology, recovery plan and outbreak management plan across North East Lincolnshire.

Members were concerned about people following the rules around households meeting up over Christmas and maintaining social distancing. They felt it would be a shame not to follow the rules and undo the good work already been done to bring the R rate down during the second national lockdown. Members queried what communications were being sent out to reinforce the message. Mr Pintus explained there were a number of different communications going out over the next few weeks, including a focus on the outcome of the which tier North East Lincolnshire would be in once we came out the second national lockdown.

Members noted the intention in the briefing to focus on community testing and queried if there was pressure for North East Lincolnshire Council to adopt mass testing across the borough. Mr Pintus explained that there was considerable resource required to carry out the mass testing programmes like the one conducted in Liverpool and he confirmed that we did not have the resource locally and there was a question about effort against return. He felt that the biggest impact was a targeted approach in the community.
