STATEMENT OF ALISON KATE SAXBY

Introduction

- 1. My name is Alison Kate Saxby and I am a Licensing Officer in the Licensing Section of the Humberside Police based at Cromwell Road Police Station, Grimsby. I cover the county of North East Lincolnshire. I am under the direction and control of the Chief Constable of Humberside Police ('the Chief Constable'). My duties include consideration of the impact of crime and disorder and the Chief Constable's response to licensing matters.
- 2. I have been a Licensing Officer since April 2018, prior to which I was a Finance Assistant for 4 years, a Public Service officer for 2 years and an Anti Social Behaviour Researcher for 2 ½ years. I have worked for Humberside Police for 13 years, therefore I am familiar with problems of alcohol related crime and disorder in both in my current and previous roles.
- 3. The Respondent, Mr Sandeep GADDU, is the premises licence holder for the premises licence granted under Part 3 of the Licensing Act 2003 ('the Act') in respect of the premises known as Go Local, situated at 52 Littlefield Lane, Grimsby, North East Lincolnshire, DN34 4PL. Premises Licence PM000648 relates to the premises.

4. I make this statement in support of the Chief Constable's review of the premises licence under Section 51 of the Licensing Act 2003 and is in addition to those papers already served on the authority. This is also submitted in support of the review papers submitted by Immigration. The information in this statement is either within my personal knowledge or is taken from files maintained by the Chief Constable.

Background

- The Respondent is the Premises licence holder in respect of the Premise Licence, with his wife, Barinderjeet Gaddu as the DPS at the premises, having applied for the transfer of the licence in April 2016.
- The premises is situated in a primarily residential area in Grimsby, with a small number of businesses nearby, including takeaways and another food shop. (EXHIBIT AKS/01)
- 7. The premises licence permits the sale of alcohol Monday to Saturday 0800 to 2100 and 1000 to 2100 on a Sunday.
- 8. The licence is subject to conditions in addition to those that are mandatory they are listed in Annex 2 of the licence. (EXHIBIT AKS/02)

History

 On 8th September 2022, Humberside Police joined Immigration in a joint visit to the premises, as well as a simultaneous visit to a second premises ran by the same family at 117 Chelmsford Avenue, Grimsby. This was due to intelligence received by the Immigration service regarding an Illegal worker employed at both shops.

- 10. On arrival at 52 Littlefield Lane, at 17:45hrs, Immigration officers entered the shop first under Section 179 of the Licensing Act 2003, followed by a Police Licensing Officer. A male was located behind the counter and a female was located at the rear of the shop. The female was not working at the time but did work at the shop and was found not to be of concern.
- Immigration officers spoke to the male behind the counter, however despite nodding his head to what was being said, it became apparent he did not understand English, therefore enquiries were completed using an interpreter on the telephone. Initially the male provided an incorrect spelling of his name, which resulted in checks finding no match. Further checks after being arrested identified the male as who had a valid visit visa, which prohibited undertaking any form of employment whilst in the UK.
- 12. Around 5 minutes after authorities entered the premises, Sandeep GADDU entered the store. He stated that he had been out of the shop for only 10 to 20 minutes due to a delivery.
- 13. Sandeep GADDU was spoken to by Immigration, where he confirmed he was the owner of the premises, and the shop at Chelmsford Avenue. He stated the doesn't work at the premises; was behind the counter watching cricket whilst he went to collect a delivery and made sure no one stole anything whilst he was out. He stated that if a customer was to enter, they would be asked to wait.
- 14. At this point the Immigration Officer was made aware that a male was also encountered at the Chelmsford Avenue shop that shouldn't be working there. When asked about who was currently working at the other shop, he said the female that was at the back of the shop

they were in. He couldn't explain why she was at the wrong shop. The male at the other shop had previously been arrested in November 2021 for working illegally at the same premises. GADDU denied knowledge of allowing him to work there again.

- 15. Sandeep GADDU was further questioned regarding his time out of the store. He stated that people would be happy to wait for 10-20 minutes as it is a family friendly shop, and customers would wait for him to go to the toilet. He was challenged on this due to the concern previously expressed around stealing, to which he said there is more chance at night.
- 16. Police Licensing then spoke to him regarding his licence. Two conditions on the licence cover CCTV:
 - CCTV shall be installed at the premises and shall cover entry and exit points, the store area, the sales counter and areas where alcohol is displayed.
 - All CCTV recording shall be kept for a minimum of 31 days.
 He stated that the CCTV recorded for 10-15 days, then changed it to 15 days. He was asked if he was aware of the licence conditions, to which he stated he was, but it wasn't his licence, it was in his wife's name.
- 17. Police Licensing and an Immigration Officer then asked to view the CCTV system. Sandeep GADDU stated he did not know how to use the CCTV system but allowed the officers to use it under his supervision.
- 18. Checks on the CCTV showed the system only held recordings until 20th August 2022, which was 19 days prior. Mr GADDU was informed he was in breach of his premises licence due to this.
- 19. CCTV was checked for the 8th September 2022, and it showed that was in the shop by himself at 15:31hrs and at 16:30hrs the same male was serving behind the counter. No other members

of staff were present at the shop during the times checked. The time on the CCTV was found to be 4-5 minutes out.

- 20. After viewing the CCTV, he finally admitted that had been working at the shop.
- 21. Licensing requested to see other items that were specified on the premises licence a training record, a refusals log and a list of staff authorised to sell alcohol but he could not supply any. This confirmed further breaches of the premises licence. The premises had previously been visited in November 2021 following a similar visit, and breaches were found then, with words of advice provided.
- checked. He repeatedly denied working at the shop, stated he didn't get paid as it was his brothers shop. He could not provide an explanation when it was put to him that he had been observed working the counter, serving customers, operating the till and handling money. He did eventually admit that he sometimes serves customers if his brother (Sandeep GADDU) wasn't there, and also his brother had contacted him when he required help but remained adamant he wasn't working there.
- 23. was taken away by Immigration officers at around 19:05hrs, where he was served Immigration forms stating his leave was curtailed with immediate effect due to him working, which was in breach of his visa, and placed on Immigration Bail. (EXHIBIT AKS/03)
- 24. The DPS, Barinderjeet GADDU, did attend the shop late on due to dealing with the visit at the Chelmsford Avenue store.
- 25. Under Section 182 of the Licensing Act 2003 (Revised Guidance April 2018), section 2 refers to the Licensing Objectives, starting with Crime and Disorder. Subsection 2.6 specifies "The prevention of

- crime includes the prevention of immigration crime including the prevention of illegal working in licenced premises". This is a clear undermining of the Licensing Objective.
- 26. Subsection 11.27 refers to certain criminal activity in a licensed premises that should be treated particularly seriously, one of which is for employing a person who is disqualified from that work by reason of their immigration status in the UK. It goes on further, in 11.28 to state that if it is determined that the crime prevention objective is being undermined, it is expected that revocation of the licence even in the first instance should be seriously considered.
- 27. Humberside Police make this representation in conjunction with the Immigration Service.

Submissions

- 28. The view of the Chief Constable is that there has been a clear breach of the law regarding employing an illegal worker. Denials had been made by both the Premises Licence Holder and his brother the employee however CCTV confirmed that this was in fact not the truth, and when challenged, there was an admittance of employment by the Premises Licence Holder.
- 29. There was also the same issue of an illegal worker at another premises ran by the owners that was found on the same day, which shows a complete disregard for the Crime and Disorder Licensing Objective, and the law regarding Illegal Workers.
- 30. A number of licence breaches were also found on the visit, which are in place to ensure the premises runs a safe premises and uphold the licensing objectives. This was after a verbal warning the year before. A warning letter was subsequently sent detailing these breaches.

31. It is the view of the Chief Constable that revocation should be seriously considered, as per the Section 182 Guidance, even in the first instance. Whilst consideration has been given to whether this can be dealt with by way of conditions or suspension, the premises are aware of the laws regarding permissions to work having been fined for an incident 10 months prior at another premises in the area. If the committee disagree and are minded to suspend and place conditions on the Premises Licence, please consider Annex 1 for suggestions.

32. The Chief Constable requests that the Licensing Committee consider the points made within this statement and asks that they refuse this application.



MC4. A relevant person shall ensure that no alcohol is sold or supplied for consumption off the premises for a price which is less than the permitted price.

I am a Police Constable in Humberside Police currently I hold the post of Alcohol Licensing Officer at Cromwell Road Police Station, Grimsby.

On Thursday 8th September 2022 I was on duty in full uniform in company with officers from the Immigration Service. The Immigration Officers believed that there a person working at Go Local shop, 52 Littlefield Lane, Grimsby illegally.

At 1745 hours I attended the Go Local shop, 52 Littlefield Lane, Grimsby with Immigration Officers. I would describe the shop as a small convenience store, which sells various household and food products. The shop has a premises licence to sell alcohol.

These are the conditions of Annex 2 of the Premises Licence:

CCTV shall be installed at the premises and shall cover entry and exit points, the store area, the sales counter and areas where alcohol is displayed.

All CCTV recording shall be kept for a minimum of 31 days

Staff shall receive regular training

Date: 16/09/2022

A refusals log shall be kept and entries made of all occasions where staff have requested identification prior to sales of alcohol

A list of staff authorised to sell alcohol at the premises shall be displayed

A waste bin shall be provided to the exterior of the premises

Alcohol shall not be consumed in the premises

Challenge 25 material shall be displayed at the premises

'Alcopops' shall not be located for sale adjacent to the confectionary

The front of the shop has two windows either side with a glass door set back in the middle of the windows. The windows have posters advertising what they sell inside. The shop floor area is approximately 7 metres by 5 metres. Once inside the serving counter to the left and runs about 2 ½ metres. Behind the counter there was a cigarette and tobacco cupboard and various spirits. Further along the left there was various wines, beers, lagers and ciders displayed on shelves and in fridges. There was one central aisle with a same aisle at the left near to the alcohol displays and on the right was a fridge and magazines and newspaper. At the rear of the shop was a doorway on the right which led to the storeroom and living quarters.

Once inside the Immigration Officers spoke with person serving behind the counter which they had to do through a phone interpreter. One of the other Officers spoke with a female at the rear of the shop.

After about 5 minutes a male entered who I recognised as the owner and Premises Licence Holder, as I have dealt with him on a previous occasion through police contact. He identified himself as Sandeep GADDU he stated that he had only been out of the shop 10 to 20 minutes as he was dealing with a delivery.

I covered the door of the shop while Immigration Officers spoke with the people in the shop.

At 1755 hours I spoke with Mr GADDU introducing myself as part of Police Alcohol Licensing, I discussed the conditions on the premises licence one of which was the CCTV conditions. Mr GADDU stated that his CCTV only recorded for 10 to 15 days, this then changed to 15 days. I asked him if he aware of the licence conditions he stated, "YES, BUT ITS NOT MINE ITS IN MY WIFE'S NAME."

I informed him that I would have to view the CCTV system to see if this was accurate.

At 1820 hours Mr GADDU showed me upstairs to where the CCTV system was located. Mr GADDU stated he did not know how to use the CCTV and let me use the CCTV under his supervision.

The CCTV only recorded back to 20/08/2022 which was less than the 31 days required on the Premises Licence. I informed Mr GADDU that he was in breach of his licence conditions as it should be 31 days and that he was warned about this in November 2021.

I reviewed the CCTV at various dates and times from 20/08/2022.

At 1630 hours on Thursday 8th September 2022, CCTV showed the same male behind the counter serving customers with no other members of staff. The CCTV system showed the correct date but was 3 to 5 minutes slow.

At 1531 hours on the above date CCTV showed the same male in the shop by himself.

I again informed Mr GADDU that he was in breach of his licence because of the CCTV. I asked him if he could show me a training booking, a refusals book and a list of staff authorised to sell alcohol. Mr GADDU stated he could not supply any of this information.

At 17:45hrs on 08/09/2022 I arrived in the vicinity of the Go Local convenience store located at 52 Littlefield Lane, Grimsby, DN34 4PL. Power of entry for the visit was under Section 179 of the licensing Act 2003. The team visiting consisted of Immigration Officer In Charge of the visit, Chief Immigration Officer Immigration Also present and assisting the team was a Police Officer known to me as PC Immigration Officer and and myself took up position at the rear of the premises whilst Immigration Officer Chief Immigration Officer and PC entered the shop from the front.

At 17:47hrs Immigration Office and and myself received an instruction via airwaves radio to enter the shop via the front. Upon entry at 17:48hrs I observed one individual who later became an anational who was stood behind born (known to me as the shop counter and was the only person present other than Immigration or Police officers.

Immigration Officer asked me to speak to him regarding his Immigration status. Interview with Mr commenced at 17:49hrs using Bigword Interpreter P22814 over the phone. Mr initially provided me with a different spelling of his name which resulted in initial checks finding no match. At 18:06hrs I arrested Mr as a person who I suspected to be subject to



Home Office checks identified a match for the He had been issued with a visit visa valid which had been issued and was valid from 23/03/2022 and expired on the 23/09/2022. The provisions of his visa granted him permission to enter the United Kingdom as a visitor but prohibited him from undertaking any form of employment whilst in the United Kingdom.

Interviewed from 18:06hrs until 18:50hrs specifically in relation to his work activities at the shop. He repeatedly denied working at the shop and stated he did not get paid as it was his brothers shop. When I put it to him that he had been observed on CCTV footage for at least an hour and half prior to our arrival working on the counter, serving customers, handling money and operating the till he could provide no explanation. He did state that "WHEN MY BROTHER IS NOT IN THE SHOP I SOMETIMES SERVE CUSTOMERS" and admitted during questioning that his brother contacted him when he required help at the shop though remained adamant that he was not working there despite the evidence he clearly had been.

Having considered the information available to me I deemed that had entered the UK using a valid visa but that he had been working in breach of the conditions of that visa in breach of Section 24(1)(b)(ii) of the Immigration act 1971, as amended.

the Immigration cell van. All officers left the store at approximately 19:05hrs and was transported to Birchin Way Police custody suite in Grimsby where I served Immigration forms on informing him that his leave was curtailed with immediate effect due to him having worked in breach of his visa. I placed him on Immigration Bail, as authorised by Chief Immigration Officer further prohibiting him from working whilst in the United Kingdom.
