**Representation by a Responsible Authority following an Application to Review Premises Licence or Club Premises Certificate**

Representations may be made at any time during a period of 28 consecutive days starting on the day after the application for review was given to the Licensing Authority.

Representations must be relevant to the application. To be relevant they must relate to at least one of the four **Licensing Objectives** listed below:

- **The Prevention of Crime and Disorder**
- **Public Safety**
- **Prevention of Public Nuisance**
- **The Protection of Children from Harm**


Objectives	Evidence
<p>The Prevention of Crime and Disorder</p>	<p>Humberside Police support Immigration in seeking a review of this premises licence. A joint visit was conducted at the premises with Police and Immigration, where a male was located working at the premises, who was identified as the brother of the owner. He was in breach of his visa conditions by working at the premises so had no legal right to be working at the premises. Immigration officers arrested the male at the location.</p> <p>A request by Immigration has been submitted for a civil penalty notice, the outcome of which is still pending.</p> <p>Immigration offences, including Civil Penalties, are a clear breach of the Crime and Disorder Licensing Objective.</p> <p>Humberside Police reserve the right to serve further evidence in due course.</p>
