Prevention of Public Nuisance	The building alterations are adding additional skylights and rear doors which will increase the noise transfer to our property. The outdoor seating area and patio sound system will cause a disturbance. This will impact on our personal enjoyment of our property and a loss of amenity. The enlarged bar area may well lead to more deliveries and emptying of bottle skips. The bottle collection is often at unsociable early hours of the morning. The vicinity to our property means that our sleep is disturbed.

If possible please suggest alterations to the application that would resolve the problem mentioned above, again paying attention to the licensing objectives

The time of deliveries and recycling/waste collections should be restricted to sociable hours

The number and specification of the sound system should be appropriate to the size of space, and I believ levels are being limited.

The rear doors should remain closed when the kitchens and bars are in use

Acoustic work should be undertaken to prevent the travel of noise from Thorpe Park to the conservation area and tranquil holiday setting of Humberston Fitties

The extraction and air handling units at the rear of their property should be maintained and replaced if the rattling cannot be repaired.
