**The prevention of crime and disorder:** I feel that there is already an abundance of late night drinking establishments and this building borders the start of residential Cleethorpes....it is close to a long established residential home providing care for vulnerable & elderly residents including those with dementia & maybe even end of life care. It is also close to a property housing adults with learning difficulties who are being encouraged to integrate with our local community. Some have lived there happily for many years.

I feel the application for late night drinking will be detrimental to the enjoyment of these peoples homes and the amenity that nearby residents are entitled to.

**Public safety:** The late night drinking may cause anti social disturbances and alcohol related violence that is already prevalent at similar establishments in Cleethorpes... this building is away from the strip of late night drinking & we need to ensure it can only operate as a restaurant and not develop into a club.

**Prevention of public nuisance:** As residents we are entitled to enjoy the peace & quiet of our own homes & not be disturbed by late night revellers & the disturbances they may attract.
