**The prevention of crime and disorder:** The venue will/may require door security staff to keep order and a licence to play recorded amplified musical until midnight suggests that disturbance could well occur on a regular basis, bringing with it anti-social behaviour resulting in a detrimental effect on the amenity and wellbeing of nearby residents, particularly the elderly and vulnerable.

**Prevention of public nuisance:** The restraunt owners are proposing to be an amplified music premises serving alcohol until 11pm during the week and until midnight at the weekend, the front doors of which are directly opposite a care home registered for 30 elderly or dementure clients in a residential area adjacent to guest house/s and domestic housing to the rear. The amplified music noise, even with windows and doors shut will cause a public nuisance in this residential area.

If possible please suggest alterations to the application that would resolve the problem mentioned above, again paying attention to the licensing objectives: I feel a restaurant business venture is perfectly acceptable, but this application for late night amplified music serving alcohol moves it away from a restraunt to something else entirely. On that basis I would suggest that it would be more appropriate in the Market Place or High Street, where such night-time venues already appear to flourish rather than a residential area.

I feel that background music rather than amplified and alcohol being served only with meals would be more appropriate.

Please keep the vulnerable residents of the care home, the dedicated staff who look after them, and the holidaymakers who choose to visit Cleethorpes and stay in its guest house, in the forefront of your mind whilst considering this application.
