Which of the licensing objectives does your representation refer to? (Select all that apply): The Prevention of Crime and Disorder, Public Safety, Prevention of Public Nuisance

**The prevention of crime and disorder:** Grant of license as described above would negatively impact community safety and cause nuisance to the residents of Isaacs Hill and surrounding streets. The closest residential property to 2-4 St Peter's Avenue is 1 Isaacs Hill 38m away (measured as the crow fly's door to door) and on the opposite side of Isaacs Hill is The Old Library Care Home which is 45m away from the door of 2-4 St Peters Avenue. Currently, the closest licensed premises to both residential properties is The Scratching Post 132m and 121m away respectively (measured as the crow fly's door to door) which has little impact on the residential properties due to the natural separation provided by High Street Pay & Display Car Park. If the proposed activities and hours are approved, the impact will be significantly more pronounced simply due to the proximity to residential properties.

It should be noted that the residents of The Old Library are particularly vulnerable people and consideration should be given to whether the proposed licensable activities are appropriate for this location and the residents of neighbouring properties.

**Public safety:** The late hours listed in the application give rise to concerns over alcohol-fuelled crime and disorder often linked to this type of establishment; as previously mentioned there are vulnerable residents in the immediate locality, on whom the impact of witnessing anti-social or disorderly conduct could be far greater than that of the average individual.

**Prevention of public nuisance:** Further to the concerns over anti-social behaviour, the potential for noise nuisance would be greatly increased should the license be granted as per the application especially after closing at the proposed late hour of 01:00 am; impact on residents from both customers exiting the establishment and noise associated with shutters closing would be unreasonable.

If possible please suggest alterations to the application that would resolve the problem mentioned above, again paying attention to the licensing objectives: The aim of this representation is to demonstrate that this location is not appropriate for licensed and/or late-night activities; the town has many licensed outlets in more suitable locations. The negative impact on residents far outweighs any perceived benefit associated with granting this license.

A more appropriate option, could be to permit sale of alcohol for consumption on the premises only and for this to be exclusively available to customers who are eating at the establishment. Hours during which alcohol can be sold & music played to be limited to 22:00 daily. Late night refreshment license should not be permitted in any form.
