CONTRIBUTION TO OUR AIMS

The Council has two clear strategic priorities – stronger economy and stronger communities. Having better polling districts and polling places will enable more electors the opportunity to engage in local and national democracy.

EXECUTIVE SUMMARY

This report sets out the feedback received to the consultation phase which was undertaken between 2nd and 31st October 2023. The report sets out the proposed changes to the polling districts and polling places and makes recommendations to the Returning Officer on replacement polling stations which can be used.

RECOMMENDATIONS

1. That the responses in Appendix 1 to the consultation on the polling district and polling place review be noted.
2. To agree the polling districts and polling places as set out in Appendix 2 with effect from the date the electoral register is published.
3. That the Returning Officer be asked to consider the proposed changes to the polling stations, as set out in Appendix 2, for use at the May 2024 elections.
4. To authorise the Electoral Registration Officer to undertake the remaining administrative tasks to conclude the review, including re-numbering polling districts if appropriate and amending the polling places for the outstanding polling stations.

REASONS FOR DECISION

Under the Representation of the People Act 1983, the council has a duty to divide its area into polling districts and to designate a polling place for each polling district.

1. BACKGROUND AND ISSUES

- 1.1. The Electoral Registration and Administration Act 2013 requires North East Lincolnshire Council to carry out a review of its polling districts and polling places every five years. The last formal review was held in 2019. Under section

18C of the Representation of the People Act 1983, the next compulsory review must now be undertaken within a 16-month window between 1st October 2023 and 31st January 2025.

- 1.2. The Boundary Commission for England has recently undertaken a review of parliamentary constituency boundaries and have now published their final recommendations. The Orders for the new boundaries will be made on 29th November 2023. Once the Orders for the new parliamentary boundaries have been made, the new boundaries will be used for the next Parliamentary election.
- 1.3. The next polling district and polling places review will be undertaken upon the completion of the North East Lincolnshire Council Ward Boundary Review at end of October 2025.

The Review

- 1.4. At the meeting of Council on 28th September 2023, Members agreed the following methodology for the review of the Polling Districts and Polling Places.
- 1.5. A reasonable methodology must be demonstrated if a successful appeal (with its consequential reputational damage) is to be avoided. The Guidance stresses the need for all decisions made to have been consulted upon and to be measured and practical: "The whole process should be as transparent and open as possible to avoid possible conflict". The initial proposals document sets out the considerations taken into account in drawing up the proposals and such an approach reduces the suggestion that decisions may have been politically motivated.
- 1.6. The primary considerations for every review are a requirement of Electoral Law and are:-
 - The Council must seek to ensure that all electors have such reasonable facilities for voting as are practicable in the circumstances; and
 - The Council must seek to ensure that so far as is reasonable and practicable, every polling place is accessible to electors who are disabled.
- 1.7. There is no scientific formula or set of rules for the division of a constituency into polling districts, nor for the selection of polling places or polling stations. The choice will often be the balance between a number of competing considerations (e.g. quality of a building and distances between the residents to that building, compared to other options for polling places). Judgement needs to be exercised (e.g. when comparing the potential disturbance to voters against other factors). However, in carrying out the balancing exercise, the approach should be voter-centred.
- 1.8. Officers propose to use the following criteria for the review:-

- Disparities between polling districts to make them more comparable in terms of number of polling places and the number of electors per polling place;
- Current levels of satisfaction / dissatisfaction as expressed by or on behalf of electors;
- The cost / elector ratio of providing a polling place, so there is a broad comparability between districts;
- The availability of postal votes on demand;
- Disturbance to electors which would be caused by alteration of polling places which have been used for a long period of time;
- A polling place should be in its own polling district, unless it is not possible to find a suitable place in the district;
- There should not be major barriers between the voters and their polling place. Major roads, rivers and the like can therefore be considered as starting points for polling district boundaries unless there is good quality, accessible crossing points;
- The polling place should not be difficult to locate and should be close to where most of the electors in the polling district live;
- The topography of the area should be taken into account including availability of public transport for electors having to travel distances to the polling place;
- That each parish should be a separate polling district save in exceptional circumstances;
- If there appears to be a need in all or particular elections (considering, for example, UK Parliamentary elections may have a higher turnout than local government elections) for multiple polling stations in a polling place, it will need to be considered if the polling place can accommodate them;
- Capability of the polling place to cope with peaks of electors allocated to it.

- 1.9. It should be noted that the considerations are not weighted, as proposals need to be voter-centred and the exercise of judgment and the balancing exercise needs to have this at the forefront of consideration. Each proposal/representation will have circumstances peculiar to it and the differing considerations relating to those circumstances must be balanced to allow the outcome to be voter centred.
- 1.10. At the meeting of Council on 28th September 2023, Members agreed to hold one round of public and stakeholder consultation. The consultation was aimed at seeking views and suggested changes on the current arrangements and on some proposed changes by the Returning Officer. The views expressed have now been considered and further changes are laid out in the schedule at appendix 2.
- 1.11. A public notice for the consultation period was placed on the Council's website on 2nd October 2023. Emails explaining the review and inviting participation in the consultation were sent to Elected Members, Members of Parliament, local political parties, town/parish council clerks and recent staff who have worked on polling stations. Internal and external social media posts regarding review were also promoted including emailing the Councils consultation members list (roughly 5,000 residents who have subscribed to receive our mailing list/active

surveys), and also featured in a Sector Support Newsletter to reach our local community groups.

Feedback from Consultation

- 1.12. The review can only consider the polling districts (internal boundaries of Wards) and polling places. The polling stations used at elections are chosen by the Returning Officer.
- 1.13. There were 145 responses received as part of the consultation. The feedback is set out in appendix 1 of the report. The Returning Officer has considered the feedback and made comments / suggestions for changes which are also detailed in appendix 1. Of those individuals who responded, 84% were happy with their polling station for voting purposes and 29% of these respondents classed themselves as having some form of disability.
- 1.14. As the Polling Districts are being updated to reflect the new Parliamentary Boundaries, there is a legal requirement for the Council to republish the Electoral Register which would be undertaken on 1st February 2024 ahead of the Local Elections in May.

2. RISKS AND OPPORTUNITIES

- 2.1 On conclusion of any polling district review, the Electoral Commission can consider representations that the review process has not been conducted correctly. There are only two grounds on which a representation may state that a local authority has failed to conduct a proper review, namely:-
 - The local authority has failed to meet the reasonable requirements of the electors in the constituency; or
 - The local authority has failed to take sufficient account of accessibility to disabled persons of the polling place.
- 2.2 If the appeal is upheld, the Electoral Commission can, ultimately, make alterations to the polling places.

3. OTHER OPTIONS CONSIDERED

- 3.1 It is a legal requirement to undertake this review.

4. REPUTATION AND COMMUNICATIONS CONSIDERATIONS

- 4.1 The review requires the local authority to consult with a wide range of stakeholders as set out in regulations and allow sufficient time for consultation. This has been achieved by an open consultation period whereby any comments on the current arrangements were welcomed. Failure to abide by this duty could lead to an appeal to the Electoral Commission, as set out in Section 2, which could lead to reputational damage to the authority if the appeal is upheld. As a third of the responses were received back from individuals identifying as having a disability, this provides some reassurance that their needs are being

met through the electoral process. In addition, 84% of respondents were happy with the polling station. Where concerns have been expressed or alternative polling stations suggested, these have been investigated and some suggestions adopted. Appendix 2 sets out the response of the Returning Officer to these suggestions.

5. FINANCIAL CONSIDERATIONS

- 5.1 There will be minimal financial costs involved in undertaking the review.

6. CHILDREN AND YOUNG PEOPLE IMPLICATIONS

- 6.1 There are no children and young people implications arising from this report.

7. CLIMATE CHANGE AND ENVIRONMENTAL IMPLICATIONS

- 7.1 There are no climate change or environmental implications arising from the recommendations in this report.

8. CONSULTATION WITH SCRUTINY

- 8.1 All elected members were invited to partake in the consultation period and feedback any concerns or suggestions for consideration.

9. FINANCIAL IMPLICATIONS

- 9.1 As outlined within section 5, there are minimal costs that would result from the consultation process.

10. LEGAL IMPLICATIONS

- 10.1 The Electoral Registration and Administration Act 2013 introduced a change to the timing of compulsory reviews of UK Parliamentary polling districts and polling places. The next compulsory review must now be started and completed between 1 October 2023 and 31 January 2025 (inclusive).
- 10.2 A 'review' is all the steps set out in Schedule A1 to the Representation of the People Act 1983. The length of the review process is not prescribed, provided all the steps required by the legislation can be undertaken within it. The review process must be structured and must be conducted formally with supporting documentation.
- 10.3 The Electoral Commission guidance includes specific guidance for managing the review.

11. HUMAN RESOURCES IMPLICATIONS

- 11.1 There are no HR implications directly arising from the report.

12. WARD IMPLICATIONS

- 12.1 The proposals contained within this report will, if agreed, affect all Wards.
