


## **Data Overview**

### Consultation on New ASB PSPO's

- After engagement with stakeholders 7 ward based Alcohol PSPOs allowed to lapse due to large geographical footprint, lack of incidents and irregular enforcement action.
- Public consultation held to refresh 3 existing ASB PSPO's in Grimsby Town Centre, People's Park and Cleethorpes Resort revealed the below:-
- 1. Do you have any concerns about public space anti-social behaviour that is connected to the consumption of alcohol?"

83.42% answered yes to this question.

2. Do you feel that a PSPO which gives some powers to the Police and Local Authority would help to address this form of anti-social behaviour?"

80.54% replied yes to this question.

3. Do you support the creation of restrictions on the consumption of alcohol and related anti-social behaviour in these nominated public spaces?

92.97% answered yes to this question.

### Next Steps and Implementation

Overall, the results show high public support for the variation and enhancement with further Powers to the existing ASB PSPO's in Grimsby Town Centre, Cleethorpes Resort and Peoples Park.

- With 2 further alcohol prohibitions as follows:-
- Not to consume alcohol in breach of the Order, or anything which the constable, or authorised person, reasonably believes to be alcohol. This means that there must be associated Anti-Social Behaviour or a reasonable apprehension of such Anti-Social Behaviour.
- 2. To surrender anything which is, or which the constable, or authorised person, reasonably believes to be, alcohol, or a container for alcohol and may require that person to leave the area for up to 24 hours.
- ODR process completed and new PSPO to be lawful in the new year 2024.
- Safer Streets 5 programme of activity supports the enforcement of the new ASB / Alcohol PSPO's by Humberside Police
