#### CONTRIBUTION TO OUR AIMS

North East Lincolnshire's status as a Heritage Place for National Lottery Heritage Fund will contribute to outcomes across the Council over the next ten years. Specific focus on heritage activities will contribute to wider economic, health and social benefits, support business growth, nurture skills, enhance community interaction, and deliver better quality lives.

#### **EXECUTIVE SUMMARY**

Our joint work with Heritage Fund as a Heritage Place will build scale and capacity building on North East Lincolnshire's status as an Area of Focus for Heritage Fund from 2019 to 2024, which has seen record levels of investment from Heritage Fund into projects across North East Lincolnshire.

Our status as a Heritage Place will support the ambitions of NEL's Creativity Strategy and Heritage Fund's Heritage 2033 Strategy, accelerating the quality and quantity of heritage projects and making a significant contribution to the Borough's culture and heritage-led regeneration.

#### MATTERS FOR CONSIDERATION

The panel are asked to note the status of North East Lincolnshire as a Heritage Place for National Lottery Heritage Fund and over the lifetime of North East Lincolnshire's status as a Heritage Place provide oversight of associated projects and programmes.

#### 1. BACKGROUND AND ISSUES

North East Lincolnshire is a Heritage Place for National Lottery Heritage Fund (NLHF) and a Priority Place for Arts Council England (ACE).

The Creativity Strategy adopted in March 2022 set out the Council's vision for creativity across the Borough. In May 2022, a Creativity Board was established to develop an action plan and to deliver the objectives of the Strategy. The action plan (considered in Scrutiny in September 2022) highlights ten priorities for 2023 including promoting partnership projects and the public sector being an enabler for creativity.

Over the last year activity has included attracting additional investment into North East Lincolnshire which has seen unprecedented levels of Heritage Fund investment.

This has included £250,000 from Heritage Fund to match with £450,000 investment from

Arts Council England's Place Partnership Fund to deliver 'Create North East Lincolnshire' programme.

North East Lincolnshire has been one of 13 Areas of Focus for Heritage Fund since 2019, as part of Heritage Fund's ambitions to deliver more inclusive heritage projects. The Areas of Focus were determined by using spend per capita alongside standard indices of deprivation.

One of the key objectives of the Area of Focus was to overcome perceived challenges around investing in heritage projects and Council staff have worked collaboratively with Heritage Fund staff and local partners to promote active participation of key organisations and communities into heritage activities.

Since 2017, especially since 2020, significant amounts of Government funding have been invested in North East Lincolnshire. This includes the first ever Town Deal (Grimsby) through the Towns Fund programme, the Arts Council's Cultural Development Fund programme, Historic England's Heritage Action Zone and Partnership Scheme in Conversation Areas (PSiCA) programme, Future High Street Fund and Levelling Up funds.

Prior to the establishment of NEL as an Area of Focus, only two sizeable projects were supported in the Borough (Peoples Park in 2004 and the Cleethorpes Townscape Heritage Programme in 2016), followed by the Petersons building grant (phase 1) in 2017. Prior to 2020, the small number of grants tended to be for small projects under £10,000 with occasional grants slightly larger (e.g., Lincs Inspire's Streets and their Stories).

From 2020, there has been a significant increase in the size of the grant awards, aligned to the Grimsby Heritage Action Zone and the catalytic impact of the Heritage Starter Fund and Heritage Network, which was administered by NELC following the award of a Heritage Fund grant. Further details of the grants which were awarded by the Heritage Starter Fund were outlined in a paper presented to Scrutiny on 24 March 2022.

The following tables and diagram highlight grants that have been awarded in North East Lincolnshire since 2020.

This support has provided the foundations for North East Lincolnshire's inclusion as a Heritage Place and being part of a cohort of 20 places who will have access to a dedicated funding pot of £200m over the next 10 years.



#### 2. RISKS AND OPPORTUNITIES

NEL's status as a Heritage Place supports significant growth in NEL's heritage sector and there is a risk that the Council, partners and creatives do not maximise the opportunities provided. This is mitigated by strong internal governance and steer by the Creativity Board. Also, investment in staff to support heritage practitioners, establishment of networks and a strong working relationship with the Creativity Board and through NELC where all appropriate checks will be made.

In the delivery of the Heritage Fund projects for which the Council is responsible for, we will manage all contracts building on existing relationships with delivery organisations that ensures any issues are identified and addressed as soon as possible.

The Heritage Fund supported projects will deliver the Investment Principles highlighted in the Heritage 2033 strategy (see Appendix A for further details). These are:

- **Saving heritage**: conserving and valuing heritage, for now and the future.
- **Protecting the environment**: supporting nature recovery and environmental sustainability.
- Inclusion, access and participation: supporting greater inclusion, diversity, access and participation in heritage.
- **Organisational sustainability**: strengthening heritage to be adaptive and financially resilient, contributing to communities and economies.

There is the potential to support different projects which engage with schools, communities and audiences across the borough irrespective of where they live, how much money they have, or their background to ensure everyone has access to creativity and heritage. This minimises the potential risk of lack of access or under representation to heritage activity.

Grant investment from Heritage Fund and other funders has been attracted to North East Lincolnshire in recent years, both to the Council and other organisations enabling high quality activity to be delivered. It is therefore important to maximise the opportunities through Heritage Place to bring further funding to the borough to deliver high quality, collaborative and relevant activities.

#### 3. REPUTATION AND COMMUNICATIONS CONSIDERATIONS

Heritage Fund's work with NEL as a Heritage Place will demonstrate an inclusive and clear message to residents and visitors that heritage is for all and opportunities for meaningful participation in heritage driven projects should lead to healthier, happier and more fulfilling lives. Many activities that Heritage Fund have supported have received widespread positive acclaim from beneficiaries . It is intended to build upon this engagement and broaden the activity across North East Lincolnshire, alongside the completion of capital build projects such as the Horizon Onside Youth Zone and Peterson's Smokehouse.

The activities outlined in this report will continue to enhance our reputation with other funders including the local delivery of Arts Council England's Lets Create Strategy, which puts North East Lincolnshire in a strong position to prioritise activities and access additional funding for projects across the borough.

#### 4. FINANCIAL CONSIDERATIONS

Collaboration with Heritage Fund further demonstrates an evidence base and local

strategy for funding opportunities including Arts Council England, National Lottery Community Fund and Historic England. The approaches outlined in the creativity strategy will also influence the development of a range of activities which the Council and partners deliver aligned to Levelling Up and UK Shared Prosperity funds that has been delivered in recent years. In future, securing external funding is vital to ensure continued delivery of the agreed creativity strategy action plan for the borough.

#### 5. CHILDREN AND YOUNG PEOPLE IMPLICATIONS

The Creativity Strategy highlights the importance of heritage engagement and participation for all with a particular focus on children and young people. Many of the activities which follow will have direct benefit to children and young people by enhancing creativity in a range of settings and across the borough. This is likely to include ensuring that projects have activity and engagement plans that involve children and young people.

#### 6. CLIMATE CHANGE AND ENVIRONMENTAL IMPLICATIONS

Environment and climate change will be major considerations for projects supported by Heritage Fund, as outlined by their Investment Principles (highlighted above). Successful projects will be delivered in partnership between organisations, including those with specialist expertise to ensure that the Council's environment policies are delivered.

#### 7. MONITORING COMMENTS

In the opinion of the author, this report does not contain recommended changes to policy or resources (people, finance or physical assets). As a result, no monitoring comments have been sought from the Council's Monitoring Officer (Chief Legal Officer), Section 151 Officer (Director of Finance) or Head of People and Culture.
